### **General Purpose Specific Bequest**

"I give, devise, bequeath, \_\_\_\_\_ (insert dollar amount or item of property to be donated) to Friendship Village of Dublin, Ohio, Inc., TAX I.D. #31-0986918, [written amount or percentage of the estate or description of property] of the rest, residue, and remainder of my estate, both real and personal. ### **General Purpose Residuary Bequest**

### **Restricted Purpose Bequest**
